INTERESTING THINGS ABOUT STUDENTS AND STAFF

The 2017 MISD Retirement Celebration was held today from 4:00-6:00 p.m. There were 51 employees who retired within the last year and most of them, along with their families, attended this event to be honored.

SPECIAL EDUCATION – FOCUSING FORWARD

Beth Alberti, Assistant Superintendent, MISD, spoke about the changing role in the MISD's responsibilities to ensure that districts are providing a Free Appropriate Public Education (FAPE) to students with disabilities. All district staff, from the Superintendent down to support staff, have a role. Districts must know the requirements of FAPE, implement FAPE correctly and support areas of need. This would include items such as; child find, determination of eligibility, discipline, IEP development, secondary transition, and many more items.

This led to a discussion of efforts the county Directors of Special Education will be focusing on, to improve state assessment results. Through establishing practices of "Specially Designed Instruction" the districts will be providing evidencebased practices that will help increase student achievement in the general education curriculum. The local Directors completed a book study by John O'Conner, "Great Instruction Great Achievement for Students with Disabilities." In order for districts to increase proficiency on this subgroup of students, they must establish a Foundation of Specialized Instruction, this is on top of effective universal instruction. An example of those foundations are; drastically increase practice turns and feedback, provide explicit instruction, provide explicit and embedded vocabulary instruction, implement fill-the-gap interventions, incorporate metacognitive instruction and implement effective behavioral systems. When done in addition to core instruction, and in co-taught, pullout and in general education classes, there will be greater achievement.

Alberti concluded by saying that Directors are beginning to define what Foundation of Specialized Instruction will look like in their districts.

President Bozymowski, on behalf of the Board of Education, thanked Ms. Alberti for her presentation.
