CALL TO ORDER

Principal Velazquez introduced Stefanie Dagnall, Paraprofessional Nominee, Rockwell Middle School. Angela became a paraprofessional in 2018. This year she wrote a grant to obtain 53 bicycles and helmets for students.

Superintendent DeVault stated that on behalf of the Board, these are examples of the amazing employees we have here at the ISD. Our parents are dependent upon these employees as they are a part of their families year-round.

Board President Genest stated that we see all that you do on a daily basis, and it is amazing for our families. We appreciate you.

Chief Academic Officer, Dr. Alesia Flye, stated that there has been so much discussion on how to improve literacy outcomes. Often Michigan is a part of the national perspective. We recently had Mississippi here to develop a strong partnership with training. Dr. Flye introduced John Cafagna to give an update on NAEP scores. John presented a broad overview of student achievement which looks at trends of 4th and 8th graders. The NAEP is the highest level of data and is not meant to be a diagnostic tool, it gives more of a broad snapshot which is not a comprehensive picture. Large urban schools like Detroit have everyone take this test where other districts are randomly selected each year. In 2024 Michigan's fourth grade reading was lower than 31 states, higher than 2 and not significantly

different than 18. We know that a number of the higher ranked states align their state standards with the NAEP.

Superintendent DeVault added that we sought out Mississippi to learn from what their Governor did over ten years ago legislatively and how they maintain a consistent focus as there is no magic bullet. We need to be talking about good things. Our national data shows us ranked 43rd but there are 18 other states that are similar to ours. Thank you for all your work.
