CONSTRUCTION UPDATE

The building enclosure should take place in the winter of 25.

Each classroom will have a unit ventilation and there will be a generator for emergency power in the cafeteria.

SPECIAL REPORTS AND FUTURE BUSINESS



5. Moved by Farley, supported by White, to adjourn. Ayes: all; Nays: none. Motion carried.


