**OPEN MEETINGS COMPLIANCE**

**STATEWIDE MATH**

Nick Kostrzeba, ISD Math Consultant, presented on number sense. We know students that struggle with math carry that over to all areas and it extends on into high school and students need to engage in a daily number sense routine. Researchers created essential instructional practices in early mathematics grades K through 5. Essentials in action is a statewide project with teams of educators providing high quality instructional material to students and providing yearlong support. Year one's focus was on second grade and in year two we moved into third grade. Standards for mathematical practice are real world skills used daily and our research and evidence supports continued focus on structured curriculum in lower elementary levels.

Chief Academic Officer Alesia Flye stated that we are seeing good results in data. If we can strengthen we'll continue to get better results.

Mr. Hubler stated that improvement over kids that haven't had number sense should impact numerous other scores. Superintendent DeVault added that we are able to take complex discussions and strengthen accountability.



FUTURE BUSINESS**


Superintendent DeVault reported that given conflicting schedules, the October 23, 2024, Board meeting time may be changed to 4:00 p.m.
