Revised School Code

Michigan Administrative Rules for Special Education (MARSE)

Part 7 of the *MARSE*, rules 340.1831 through 340.1839, outlines the requirements for the development, submission, and monitoring of ISD plans. Rule 340.1832 states:

"An intermediate school district plan for special education, or any modification thereof, shall be an operational plan that sets forth the special education programs and related services to be delivered. The plan shall comply with 1976 PA 451, MCL 380.1 et seq. and these rules."

I. Public Awareness and Child Find

R 340.1832(a)

A description of the procedures used by the intermediate school district to advise and inform students with disabilities, their parents, and other members of the community of the special education opportunities required under the law; the obligations of the local school districts, public school academies, and intermediate school district; and the title, address, and telephone number of representatives of those agencies who can provide information about the special education opportunities.

R 340.1832(b)

A description of activities and outreach methods which are used to ensure that all citizens are aware of the availability of special education programs and services.

The following describes the ISD procedures for locating, identifying, and evaluating students who need special education programs and services. This includes outreach efforts for individuals incarcerated in county jails as well as other lower incident placements, like residential facilities, homebound hospitalized, etc.:

The Macomb ISD assumes primary responsibility for Child Find activities and outreach for preschool children. All local educational agencies will assume responsibility for in-school and out-of-school youth up to the age of 26 through special education programs/services and establish cooperative liaisons with other agencies and professionals who may be potential referral sources. Macomb ISD staff will coordinate Build Up activities.

Persons eligible for special education services in the Macomb Intermediate School District constituent districts may be identified through Child Find, an outreach program conducted in cooperation with constituent districts. Child Find activities are developed, implemented, and coordinated in cooperation with constituent districts, and Child Find Coordinators. Child Find and public awareness assure that the needs of students with disabilities up to 26 years of age will be met. Individuals who exhibit educational need at any age, up to age 25, may be referred. It is the joint responsibility of the constituent districts and Macomb Intermediate School District to identify persons suspected of having a disability from birth to 26 through Child Find and public awareness, including students in county jails, as well as other lower incident placements, like residential facilities, homebound hospitalized, etc.

The following describes the ISD activities, including partnerships with community agencies, and the forms of media used in the ISD outreach efforts:

The procedures for identifying potential school-age special education students may include review of existing school records and interagency collaboration for referral of student dropouts. Awareness information is provided through the distribution of Michigan Build Up materials, Early On Information, and Special Education Information from the Parent Handbook. Special Education evaluation procedures and processes will be distributed in the following manner.

- Annual advertisement in local newspapers or local radio
- Pre-school screenings for 3 to 5-year-old children

Rule # for Program or Service	Description of the Change in Program or Service
R 340.1738	Programs for students with Severe Cognitive Impairment (SCI): Consist of one teacher and three aides with 15 students. The third aide is assigned with the 13th student.
R 340.1741	Emotionally Impaired Program: One teacher with 1-2 aides to serve 12 students in a classroom at any one time with the total number of students on the teachers caseload to be no more than 15 different students. No more than 12 students can be in the room at any one time; an aide will be assigned when the 11th student is added.
R 340.1742	Deaf and Hard of Hearing: Caseload of 12 with no more than seven students at one time at the elementary level. A caseload of 12 with not more than 10 students at one time at the secondary level.
R 340.1739	Programs for Students with Moderate Cognitive Impairments: Post-Secondary programs or services for students with an IEP (18 and older) who are in Post-Secondary programs or services will modify R340.1739(b) under the caseload provisions of this rule. R 340.1739: 3 instructional aides for a maximum of 30 students with not more than 10 students per aide, or one teacher and one aide for a maximum of 15 studentsat one time. A second aide will be required with the addition of the 16th student and a third aide with the addition of the 21st student. This applies to LEAs, PSAs and/or the ISD which may provide transition services via a consortium agreement(s) for certificate of completion post-secondary students.
R 340.1744	Programs for students with Physical Impairment or Other Health Impairment: A total of 12 students in the classroom at any one time with the addition of an aide while maintaining the maximum caseload for the specific teacher at not more than 15 different students. The aide will be added with the 11th student.
R 340.1745	Services for students with Speech and Language Impairment: Maximum caseload at 60 students with no more five additional under evaluation.
R 340.1748	Severe Multiple Impairments Program: Provide 1 teacher and 2 instructional aides for a maximum of 10 students.
R 340.1749a	Elementary Resource Program: Maximum of 15 students at any one time, with a caseload of 23 students.
R 340.1749b	Secondary Resource Program: Maximum of 15 students at any one time, with a caseload of 25.
R 340.1749c	Departmentalization of Special Education Programs: An average of 13 students per class period per instructional day, with not more than 15 at one time.
R 340.1756	Programs for students with Severe Language Impairment: An aide to assist with the increased class size will be assigned with the addition of the 12th student. Maximum number of students at any one time is 12 students.
R 340.1758	Programs for students with Autism Spectrum Disorder: ASD elementary or secondary classroom programs class size consists of an ASD teacher, 8 students, and 2 instructional aides. The second aide will be added with the 6th student. The IEPT will describe its consideration of the ability of the student with autism to function in the placement determined, in the context of class size and student-to-staff ratio.
R 340.1749	The teacher consultant shall carry an active caseload of not more than 30 students with disabilities. All students served under this rule shall be counted as part of the caseload. In establishing the caseload, consideration shall be given to time for all of the following: (a) instructional services, (b) evaluation, (c) consultation with special and general education personnel, (d) report writing, (e) travel.
R 340.1754	Early Childhood Special Education Program - Not more than 14 students for 1 teacher and 1 aide at any one time, and the teacher shall carry an active caseload of not more than 28 different students.

The Social Worker Specialist cannot: • Serve as a MARSE required member of the MET and IEP teams in the identification of a disability and development of supports and/or services to enable a qualifying student to learn as effectively as possible in his or her educational program.

Certification and/or endorsement of the teachers and service providers

An individual may be employed under the social work specialist with at least all the following: • A Michigan Licensing and Regulatory Affairs (LARA) licensed bachelor level social worker • Be enrolled in a Master of Social Work, with a school social work approval program at an accredited university. • Work under the direct supervision of the local district Administrator of Special Education Programs. • Must be supervised by a Michigan LARA licensed master level social worker with full approval as a school social worker • Must make progress toward the Social Work master's degree each year by successfully fulfilling the university obligations to remain in the program. • Candidates must complete the master's program in 3 years and receive temporary approval as a school social worker (unless there are unforeseen university delays, such as cancelling a scope and sequence required course).

Paraprofessional personnel employed in special education programs shall be qualified under requirements established by their respective intermediate school district plan. Paraprofessional personnel include, but are not limited to, teacher aides, health care aides, bilingual aides, instructional aides, and program assistants in programs for students with cognitive impairment or severe multiple impairments.

All paraprofessionals employed in special education shall, at a minimum, be high school graduates, or equivalent, and also meet any specific requirements established by the employing LEA/PSA. Paraprofessional personnel must also meet any applicable state or federal requirements.

VI. Millage Fund Distribution

R 340.1811

- (1) Only those programs and related services provided under a department-approved intermediate school district plan and approved for reimbursement by the department shall be eligible for reimbursement from funds generated by adoption of millage under sections 1723 and 1724 of 1976 PA 451, MCL 380.1723 and 380.1724.
- (2) If intermediate school district special education tax funds are insufficient to reimburse constituent claims in full, then a like percentage of the claim shall be paid for support of each program and service to each constituent district. Claims for operation of special education programs and services available to all constituent local school districts or public school academies may be reimbursed in full before any prorated payment which may become necessary for other programs and services.
- (3) Current intermediate school district special education tax funds need not be used to offset operational claim deficits from prior years.
- (4) Amounts may be retained by the intermediate school district for required cash flow purposes not to exceed 1 year's operational expenses for the purpose of maintaining special education programs and services operated by the intermediate school district.
- (5) Intermediate school districts shall submit the desired method for the distribution of funds to the intermediate school district, its constituent local school districts, and public school academies and the reasons therefor for approval as part of the intermediate school district plan required under section 1711 of 1976 PA 451, MCL 380.1711.

R 340.1812

- (1) Costs for the operation of special education programs and services by the intermediate school district, available to all constituent local school districts and public school academies, may be reimbursed in full before the reimbursement of local districts from funds generated by adoption of millage under sections 1723 and 1724 of 1976 PA 451, MCL 380.1723 and 380.1724.
- (2) If intermediate school district special education personnel offer direct services to students with disabilities in some but not all constituent local school districts or public school academies, and if prorated payment of constituent local school district or public school academy operational claims is necessary, then the per capita deficit for each student served shall be paid by the school district of residence or a direct charge shall be made to the constituent local school district based on the amount of deficit and the proportion of time the constituent local school district or public school academy received the service from the intermediate school district.

The following is the method of distribution for millage funds in the ISD that meets the requirements of R 340.1811 and R 340.1812.

Special Education Millage Funds will only be used to provide special education programs and services for students who are residents of the Macomb Intermediate School District. Special education funds will be appropriated in the following priority in accordance with the Macomb Intermediate School District's approved budget:

- Full reimbursement for special education programs and services provided by the Macomb Intermediate School District.
- 2. Full reimbursement for Macomb Intermediate School District center programs, and for locally operated center programs.
- Full reimbursement of room rental for facilities used for special education classrooms.
- 4. If additional Special Education Millage Funds are available after funding the previous three items, the Macomb Intermediate School District will determine which of the following methodologies will be used to reimburse local districts for the cost of providing special education programs within those local districts.
 - Special Education Millage Funds may be dispersed to constituent local districts/PSAs based on a prorated share of the total number of student Special Education FTE on the previous school year's fall count that are MISD resident special education students.
 - ii. Special Education Millage Funds may be dispersed to constituent local districts/PSAs based on a prorated share of the previous school year's unreimbursed special education costs. This would be based on the total special education expenditures as reported to the Macomb Intermediate School District on the State's DS 4096 and DS 4094 Special Education Cost Reports, reduced by the Special Education funding, excluding the Special Education Foundation portion.
 - A combination of options a & b above.

In the event center program added costs of priorities 1 and 2 above are not appropriated at a 100% funding level (combined funding of Section 52 and Special Education Millage), the Macomb Intermediate School District will determine which of the following methodologies will be used to charge constituent local districts/PSAs districts:

- 1. Prorating the total unfunded balance by the total number of Center Program FTE memberships as of fall state count day.
- 2. Prorating the total unfunded balance by the constituent local districts/PSAs share of the previous school year's unreimbursed special education costs (as outlined in 4.b above).
- 3. Prorating the total unfunded balance by the total number of all Special Education FTE memberships as of fall state count day.
- Charging constituent districts, a prorated share of the unfunded costs of students attending center programs, excluding SXI and SCI program students.
- A combination of the above options.

These charges shall be paid to the Macomb Intermediate School District for distribution and shall be an integral part of the budgeting process.

***No local educational agency or charter school will receive more than 100% of the previous school year's total special education expenditures as reported to the Macomb Intermediate School District on the State's DS 4096 special education final cost report.

VII. Parent Advisory Committee (PAC)

It shall be the responsibility of the Assistant Superintendent of Special Education or his/her designee to assure that the PAC representatives are provided with copies of the current MISD Special Education Plan, subsequent proposed amendments and/or deviation requests.

If the PAC representatives directs that PAC leadership by majority vote, an objection to the plan may be filed according to the procedures specified in Rule 340.1836 of the *Michigan Administrative Rules for Special Education*
