## How

Here is what you need to do:

- Submit your entry by December 4, 2020
- Photos can be in color or black and white
- Students must submit their photos, digitally to <u>342021mlk@gmail.com</u> in a single email

## **High School Photo Contest**

- Only photos attached in the email will be considered
  - In the body of the email; include your NAME, AGE, EMAIL ADDRESS, HOME ADDRESS, PHONE NUMBER, SCHOOL NAME, SCHOOL DISTRICT NAME.
- All photos must be taken and edited with mobile devices (smartphones, or phones by any operating system, or tablets)
- Photos may only be edited using software available on a mobile device
- Format: jpeg
- Minimum dimension: 640 pixels on the biggest side
- File Size: larger that 100k and smaller than 7MB
- NO images that are embedded on the email
- NO images with boarders, frames watermarks
- Confirmation emails will be sent to every participant after they have submitted an entry
- The submissions will not be returned

#### The Selection Process

- Finalists will be selected by a panel that includes local artists and representatives from Anton Art Center
- The decision of the judges is final

#### Prizes

- Cash Prizes: 1<sup>st</sup>-Place \$75, 2<sup>nd</sup>-Place \$50, 3<sup>rd</sup>-Place \$25
- Featured during the 34<sup>th</sup> Annual MLK Holiday Celebration
- Promoted via social media channels (Facebook, Twitter, LinkedIn, and Instagram)
- Work will be exhibited throughout Metro Tri-County area art exhibits during the Spring of 2021

#### **Other Rules**

- 1. All submissions must conform to your school and district policies regarding appropriate content
- 2. Photos submitted after the December 4, 2020 deadline may not be accepted
- 3. Entrants agree to be bound by the official contest rules and decisions of the judges
